1. Admission requirements

The prerequisite for admission to the **Master's degree** course is a Bachelor's degree in Industrial Engineering, a corresponding technical and business-oriented degree course or a degree obtained in Germany or abroad that is equivalent to such a degree. An overall grade of 2.0 or better is required. Admission to the degree programme also requires a good command of English.

For applicants from India: a list of institutes whose Bachelor's degree programs have already been recognized as relevant by the TH Rosenheim can be found at the end of this checklist. However, Bachelor graduates from other institutes can also apply. These degrees will be reviewed by the faculty on a case-by-case basis.

2. Applications

It is possible to start studies only in a **winter semester**.

Application period:

Winter semester 15 April to 15 May (start of studies 1 October)

Please be aware that it is in your own interest to submit your application as early as possible. You must register online on our website where you will also upload all the necessary documents for your application.

Documents you should upload by 15 May at the latest:

○ **If your first/undergraduate degree was obtained at a German educational institution** (If you have not received your certificate yet, you can present your confirmation of grades as proof that you have successfully completed your first degree). You may need to upload a German or English translation produced by an officially appointed translator. It is essential that this shows the overall examination result! If you have not finished your first degree by the application deadline, please observe the information on the **last** page of this information sheet.

○ **If your first/undergraduate degree was NOT obtained at a German educational institution „uni-assist“ preliminary review documentation if applicable**

If you did not obtain your higher education entrance qualification at a German institution, you will need a **valid VPD** (Vorprüfungsdokumentation) from **uni-assist**. Uni-assist is then going to review your documents if they match the admission requirements for German universities. Please make sure to apply for a **Master VPD** (for a master's degree programme)! You can apply at uni-assist all year round: Register with uni-assist. Upload your higher education entrance qualifications/school or university leaving certificates. Apply to TH Rosenheim with your valid VPD. Your VPD is valid for 1 year.

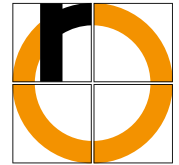

○ **Proof English language skills**

The qualification requirement for the English-language degree program is English proficiency at level B2 of the Common European Framework of Reference (CEFR) for languages. These can in particular be demonstrated by:

- Internet-based TOEFL with a score of 72 points or higher.
- TOEIC with 785 points or more
- IELTS with band 6.0 or higher
- Cambridge CEFR B2 First (FCE) with Grade C (min. 160 points) or higher
- Cambridge CEFR C1 Advanced (CAE) with Level B2 (min.160 points) or higher
- TELC Certificate English B2 or higher
- Pearson PTE Academic, 60 points or higher
- At least 6 years of school English with at least the grade „sufficient“ in the senior year, as evidenced by a German language university entrance qualification or an equivalent, recognized university entrance qualification from a non-German school
- completed English-language bachelor's or master's degree program
- completed English language studies in Germany and abroad
- A grade of at least „good“ in the module ‚Technical English‘ or a comparable English module from the previous German-language degree.

Applicants whose native language is English or who have successfully studied (usually at least 50 ECTS credit points or comparable) for at least two semesters at a university in the United

States of America, the United Kingdom, Canada, Australia, New Zealand or Ireland are exempt from providing proof of sufficient English language skills. In cases of doubt or if no proof is available, the successful completion of a language examination at the TH Rosenheim comparable to the above-mentioned proof may be required in addition or as a substitute.

○ "curriculum vitae" form

The use of the form is mandatory, otherwise your application cannot be processed. This form can be downloaded from the online application portal.

○ Diploma supplement or transcript of records

as proof that you have achieved the required number of ECTS credits during your first/undergraduate degree. You do not have to provide this document if the ECTS credits are shown on the degree certificate. Applicants who studied for their first/undergraduate degree at Rosenheim Technical University of Applied Sciences do not need to submit this document. You may need to submit a German or English translation produced by an officially appointed translator.

○ Proof of change of name, if necessary (e.g. marriage certificate)

○ Reporting procedure for health insurance in the form of an electronic report on your insurance status (M10). Please quote our sender number H0000974 and the health insurance fund will send the required report to us.

○ Proof of payment of the student union contribution to the amount of € 85,-

After you have applied for enrolment via Rosenheim Technical University online applicant portal, it will generate a PDF file for you where you can find the bank details for the student union contribution. Please make sure you state the transaction reference given here, otherwise we will not be able to allocate your payment to you!

Please wait until you receive confirmation of admission before transferring any payments!

Account statements or screenshots showing transactions are suitable evidence of this proof

○ Certificate of removal from the university register, if necessary

with details of the university semester or study times

Not necessary for applicants who studied/are studying at Rosenheim Technical University or for degrees inside of Germany

3. Applicants from non-EU countries abroad

Please send your applications in early, as experience has shown that the application procedure for a residence permit takes several weeks

4. Information for war refugees

War refugees who have a residence permit in accordance with Section 24 of the Residence Act (Act on the Residence, Economic Activity and Integration of Foreigners in the Federal Territory) can submit a **DAAD language certificate (English B2)** from TH Rosenheim's Language Centre as evidence of sufficient English language skills

If you have been admitted:

Apply for enrolment in the  **Online Application Portal** by **30 June**, missing documents can be handed in until **31 August** and also submit all the required documents to the Office of Student Administration by that date. Failure to meet the deadlines will result in exclusion from the procedure!

- You will then receive your study documents by mail
- There is no need for personal enrolment at the university
- Important enrolment information will be sent to you by e-mail

• Applicants from non-EU countries

You will receive your study documents either from the head of the degree programme or you can pick them up at the Office of Student Administration at Campus Chiemgau.

What do you do if you have not completed your first degree by the start of the semester?

In this case, Student Administration will send you temporary guest access for all online services at Rosenheim Technical University of Applied Sciences. Please get in touch with Student Administration once your overall examination result has been announced to find out about enrolment.

Enrolment will need to be denied if the first degree has not been completed by the date of the first examination in the Master's degree. Completed means that the final overall examination result must have been submitted!

What do you do if you have a first degree with at least 180 but less than 210 credit points?

In order to pass the Master's examination, **proof** must be provided **of the missing credits**, or they must be caught up from the range of relevant courses at Rosenheim Technical University of Applied Sciences. The Examination Committee shall determine which study achievements and examinations need to be taken additionally in the degree programme. In some cases, relevant vocational or professional work periods may be credited to the missing ECTS credits. Proof of a **total of 300 ECTS** credits (inclusive first course of studies) is therefore required to successfully obtain your degree qualification. Applicants with fewer than 180 ECTS credits from their first degree cannot be admitted to the Masters' degree programme.

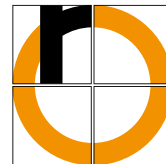

Processing status in the online applicant portal: „**Enrolment application in progress**“.

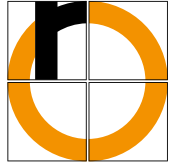
